Dragon Boat Event Waiver and Release of Liability

This Waiver and Release of Liability (herein "**Release**") by the undersigned Participant, signed below, who, intending to be legally bound hereby, agrees to release, waive, discharge, hold harmless, defend and indemnify the following **Persons and Entities Released** listed herein.

Persons and Entities Released listed herein: A.J. Jolly Park Operated by the Campbell County Fiscal Court, Paddling for Cancer Awareness, Inc, and all of their officers, officials, agents, board members, organizers, agents, participants, employees and all other persons or entities acting in any capacity on their behalf, and all Dragon Boat Event officials, coaches, sponsors and volunteers.

In consideration of being allowed to participate in any Paddling for Cancer Awareness, Inc. (DBA Kentucky Thorough--Breasts) events and/or activities, including, but not limited to, dragon boat racing and dragon boat practice, the undersigned acknowledges, appreciates, and agrees that:

1. I am aware that the risks of injury from participating in any Paddling for Cancer Awareness, Inc. (DBA Kentucky Thorough--Breasts) events and/or activities is significant, including the potential for permanent physical, mental or emotional injury and paralysis or death to me, to property, or to third parties. These risks may include, but are not limited to, among other things: boat capsize; tidal conditions and currents; collision with objects or other watercraft; prolonged exposure to cold water; hypothermia; accidental drowning; exposure to sun, heat, strong wind, cold, storms, waves, lightening; illness in remote areas; aggressive and/or poisonous marine life; wrist, arm shoulder, and/or back injuries; slips, trips and falls; and rapidly changing adverse weather and water conditions. While particular rules, equipment, and personal discipline may reduce that risk, the risk of serious injury and/or death does exist; and, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS OF PERMANENT INJURY OR DEATH, both known and unknown, even if arising from the negligent acts or omissions of any of the **Persons and Entities Released listed herein**, and I expressly assume the risk and full responsibility for and damage, injury or death resulting from my participation in any Paddling for Cancer Awareness, Inc. (DBA Kentucky Thorough--Breasts) events and/or activities;
2. I will comply with all rules, conditions and instruction required for my participation. If, however, I observe any hazard during my presence or participation in any Paddling for Cancer Awareness, Inc. (DBA Kentucky Thorough--Breasts) events and/or activities, I will immediately remove myself from participation and immediately bring such hazard to the attention of the nearest official;

I certify that I have adequate insurance to cover any personal injury that I may incur or cause to another, and to cover any damages to property that I may incur or cause to another, as a result of my presence or participation in any Paddling for Cancer Awareness, Inc.
